We recognise that this may not be easy to legislate for, and perhaps even more difficult to enforce that legislation. Nevertheless we are deeply concerned for vulnerable young people who are 'native' to the digital environment in a way that their parents are not.

Gambling advertising is very sophisticated and very well resourced. While perhaps not directly aimed at children and young people, we are deeply concerned that online gambling companies are 'grooming' the next generation of their customers. There is evidence that early gambling participation increases the risk of

problem gambling in adulthood.

We think that there should be a comprehensive set of offences concerning underage gambling. These should include preventing children from using certain gaming machines, (e.g. fixed betting terminals) and from being invited to gamble online, including online gambling games on other sites, even when there is no exchange of money. There should be age verification for all online gambling, including free-to-play gambling games through gaming or gambling apps, Facebook or gambling websites. There should be no gambling adverts during sporting events before 9 am.

#### Please provide details:

Firstly, future regulation should cover all types of gaming machine and not leave legal grey areas, as has been the case for Fixed Odds Betting Terminals.37 There should be a requirement for the Department in charge of regulation to know how many gaming machines are in operation.

Secondly, there should be a comprehensive set of consumer protection measures introduced for gaming machines, including self-exclusion, the ability to set time and spend limits, have mandatory alerts, prohibited mixed play between B2 and B3 games and algorithms to identify problematic play, and the use of tracking data as long as the data protection issues are addressed, and that data is used only with the player's consent.

Thirdly, there should be no contactless payments as a direct form of payment for gaming machines. Players should not be able to directly use their debit or credit cards with gaming machines. No credit cards should be used for any form of gambling or adding to digital wallets. A ban on credit cards for gambling will take effect in GB in April 2020

## **Gambling - Final comments**

#### Please provide details :

The Methodist Church in Ireland has always been opposed to all forms of gambling. We regard gambling as an expression of the love of money which the Bible defines as the 'root of all kinds of evil'. (1 Timothy 6:10) Accordingly we encourage all our members not to participate in any form of gambling - including the National Lottery.

We recognise that this puts us in a minority (perhaps even within Faith Groups). We know that many regard gambling as a form of harmless entertainment - and for many that may be so.

Our deep pastoral concern is for the not insignificant number of problem gamblers and the impact on them and their families. It is with these people in mind that we have responded in the way that we have, seeking to restrict some of the potential harm caused by gambling - particularly to young people.

We were particularly impressed with the recent presentation at Stormont by 'Gambling with Lives'and we join in with their call for better services for those suffering from gambling addiction.

The gambling industry clearly have very deep pockets and are a powerful lobby group. The fact that the CEO of one online betting company last year earned about one million pounds a DAY, shows in whose favour the odds are stacked!

We pray for those who will legislate on the back of this consultation in the hope that caring for the vulnerable will weigh more heavily than the love of money.
